Lupe,

Your Work Plan is approved with the following exceptions:

- S1. The top 10' of excavation is to be hauled off. The OCD would like to see the next 4' (the zone from 10' to 14') pulled out, aerated, and blended with clean backfill before being returned;
- S2. Your proposal to excavate to 16' is approved;
- S3. The OCD would like an 8' excavation. In this case, the top 4' of that excavation may be blended with clean soil and used as backfill, while the zone from 4' to 8' is to be hauled off for disposal. Alternatively, 3' excavation and a liner may be used in this area;
- S4. Approved as written.

The OCD would prefer to see at least 3' of clean top soil across the entire excavation, but will concede to BLM recommendations.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.

Mr. Robertson:

At approximately 1:00 p.m. on 6/25/2014, a produced fluid release was discovered near the above-referenced well pad. An estimated 50 barrels of produced fluid was released. The cause of the release is currently under investigation. We will follow up within 15 days with a C-141 Report. GPS coordinates, legal description and driving directions are listed below. A Google Earth snapshot showing the nearest well pad, along with an estimation of the spill path is also attached for your review.

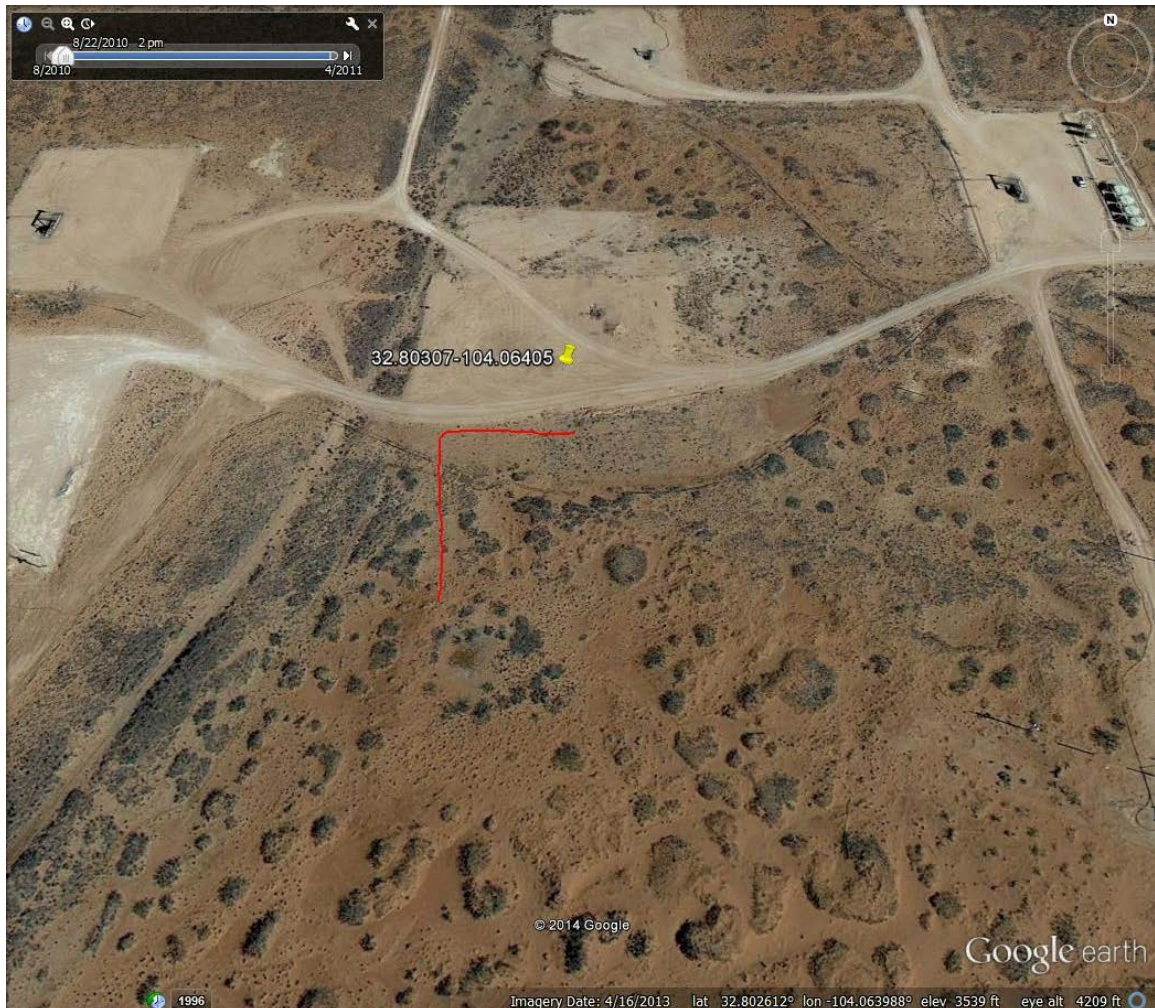
