Blm approval depends on sample results for Btex and TPH on sample points 1 and 2 around the battery. Sample point one the TPH is 9188 at 6 inches and 5000 is our limit for this location. Point 2 at SS 62,300 and the limit is again 5000 and Btex is 73.6 and the limit is 50. That being said this plan is approved pending further test results at these points. And at the time that this office receives those results a determination will be made for these two points. I understand that safety will come into play for these areas and will be taken into account.
