
Describe Cause of Problem and Remedial Action Taken.*

The release was caused by a hole in 4" gas line; gas released was ignited by static electricity from nearby power lines. This created small fire and melted 4" water line next to it. The lines were isolated to stop gas and water.

Describe Area Affected and Cleanup Action Taken.*

An area approximately 30' x 50' was impacted in the pasture near the flowline. Concho had the spill site sampled to delineate any possible contamination from the release and presented a remediation work plan to the NMOCD and the BLM for approval prior to any significant remediation work. All work has been completed in accordance with the approved work plan.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
