Ms. Patterson,

We apologize for not submitting a C-141; the reason we did not is the spill was approximately 1 bbl, and with the low volume we did not think a C-141 was required.

The lease has been cleaned up under Bill Dougherty's supervision (Nadel and Gussman's NM Field Superintendent). I spoke to Bill and as he has been on the location, saw the spill, and supervised the clean up, I asked him to get in touch with you. He said that you and he did speak by phone. Bill said that you asked that he submit current pictures so that you can see that the lease has been cleaned up, and that a C-141 was not required due to the low volume.

If any of the above is incorrect, pls let me know. If all of the above is correct, Bill will be taking pictures this afternoon and will send to you tonight or tomorrow morning.
