This closure report is denied based on an incorrect site ranking and further action required. Per the ChevronTexaco Trend map and the OSE website, depth to groundwater is less than 75 feet (see attached documents). Based on this information and a site ranking of 10, contamination above OCD RRAL's is still in place. The area of S2 will need to be excavated to 2 feet to meet the TPH RRAL of 1000ppm.
