I'm a little confused about this release. We have two releases at this site that are only a few days apart and are very similar. I've attached the C-141's. Your work plan lists 2RP-3281, but has the details of 2RP-3264.

Can you and Heather review these and make sure a) there are truly two separate spills, not one that was reported twice, and b) if there are two separate spills, which one your work plan covers (if not both).

That said, this CAP is approved as written. Please send confirmation samples to OCD for approval prior to closure request.
