Describe Cause of Problem and Remedial Action Taken.\*

A failure occurred with a check valve on the LACT unit, causing the release of crude oil. Vacuum truck(s) and roustabout crews were called.

Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 168' X 30' was affected outside of the battery on the production pad. Vacuum trucks were called to recover the standing fluid and a backhoe was called to excavate impacted soil. Excavated soils will be hauled to a NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX. If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. **Depth to Ground Water: >100' (approximately 130', Section 25, T21S-R31E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Yates Petroleum Corporation requests closure.**
