**Your work plan addresses the spray area around the release but does not encompass the entire spill area. Please see attached spill map which was GPS'd on 11/05/10 and outlines the flow from the spill release point down the access road to a second pooling area. The spill area mapped was still damp (not wet) and just beginning to show salt crusting at the time of the inspection. The spill map encompasses both the spray area and the runoff down the road. Near the end of the spill path the new spill overlapped an older spill and flowed across the top of the older spill.**
