Water pump did not come on and tank overflowed. Well shut off, called vacuum truck.

An approximate area of 20' X 100'. Vacuum truck called to pick up remaining oil and produced water, impacted soils to be scraped up and taken to an NMOCD approved facility. Bertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX, Chloride delineation/results are for documentation. If analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted. **Depth to Ground Water: >100' (approximately 300', Section 32-T18S-R25E, per NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on revegetation of release area and BLM guidance and approval, Yates Petroleum Corporation requests closure.**
