Box 248, Artesia, New Mexico 88211-0248 is dated effective at 7:00 a.m., Central time, on November 1, 2015 (said hour and day being hereinafter called the "Effective Time").

ARTICLE I Conveyance

Assignor, for Ten and No/100 Dollars (\$10.00) and other good and valuable consideration in hand paid by Assignee, the receipt and sufficiency of which consideration are hereby acknowledged and confessed, by these presents does hereby GRANT, BARGAIN, SELL, CONVEY, ASSIGN, TRANSFER, SET OVER and DELIVER unto Assignee, the following rights, title and interests (collectively, the "Purchased Properties"):

- (a) All right, title and interest of Assignor in and to the oil and gas leases and other interests described in <u>Exhibit A</u> attached hereto (and any ratifications, extensions, renewals and amendments thereof, whether or not the same are described in <u>Exhibit A</u>) (collectively, the "<u>Leases</u>") and the oil, gas, water, disposal or injection wells located on or associated with the Leases, whether producing, shut-in, abandoned or temporarily abandoned, and including the wells shown on <u>Exhibit B</u> (collectively, the "<u>Wells</u>");
- (b) Without limitation of the foregoing, all other right, title and interest (of whatever kind or character, whether legal or equitable, and whether vested or contingent) of Assignor in and to the lands described on Exhibit A hereto or covered by the Leases (including interests in oil, gas and/or mineral leases, overriding royalties, production payments, net profits interests, fee mineral interests, fee royalty interests and other interests insofar as they cover such lands), even though Assignor's interest therein may be incorrectly described in, or omitted from, such Exhibit A;
- (c) All rights, titles and interests of Assignor in and to, or otherwise derived from, all presently existing and valid oil, gas and/or mineral unitization, pooling, and/or communitization agreements, declarations, designations and/or orders and in and to the properties covered and the units created thereby (including all units formed under orders, rules, regulations, or other official acts of any federal, state, or other authority having jurisdiction, and voluntary unitization agreements, designations and/or declarations) relating to the properties described in subsections (a) and (b) above;
- (d) All rights, titles and interests of Assignor in and to the agreements and contracts by which the properties described in subsections (a), (b) and (c) above are bound or that relate to or are otherwise applicable thereto, including (X) operating agreements,

joint venture agreements, farmin and farmout agreements, area of mutual interest agreements, exploration agreements, participation agreements, exchange agreements, transportation or gathering agreements, agreements for the sale and purchase of oil, gas, casinghead gas or processing agreements and (Y) those agreements and contracts described on Exhibit C attached hereto;

- (e) All rights, titles and interests of Assignor in and to all permits and licenses (including all environmental and other governmental permits, licenses and authorizations), rights of way, easements, and other rights of surface use and water rights by which the properties described in subsections (a), (b) and (c) above are bound or that relate to or are otherwise applicable thereto, including those described on Exhibit D hereto;
- (f) With the exception of all corporate, financial, tax and legal records of Assignor (which are hereby excluded from the Purchased Properties), originals (or, to the extent originals are not available, copies) of all lease files, land files, well files, gas and oil sales contract files, gas processing files, division order files, abstracts, title opinions, and all other books, files and records, information and data (including production, engineering, geological and geophysical data), and all rights thereto, of Assignor insofar as the same are related to any of the properties described in subsections (a), (b), (c), (d) and (e) above and to the extent the transfer thereof is not prohibited by existing contractual obligations with non-affiliated third parties (the "Records"); and

ARTICLE III Miscellaneous

Section 3.1. <u>Further Assurances</u>. Assignor covenants and agrees to execute and deliver to Assignee all such other and additional instruments and other documents and will do all such other acts and things as may be necessary more fully to assure to Assignee or its successors or assigns, all of the respective properties, rights and interests herein and hereby granted or intended to be granted.

Section 3.2. <u>Production; Taxes; Costs and Expenses.</u> All Hydrocarbons and other minerals produced prior to the Effective Time (irrespective of whether payment for the same has been made or received) that are attributable to the Purchased Properties shall belong to Assignor, and all such Hydrocarbons and other minerals produced from and after the Effective Time that are attributable to the Purchased Properties shall belong to Assignee. 
