Heather,

The initial C-141 and ground water data for the Holly Station are attached. There is no groundwater reported in the immediate project vicinity. The closest wells that show up in SE's database indicate that ground water is between 30 and 90 feet. Do you want to give this site a ranking of 10?

As we discussed previously, due to the location of the impacted area we are going to move forward with the excavation of impacted soil. Once the impacted soil is removed I will take confirmation samples and provide the lab data to you along with a site map prior to backfill. Please let me know if you have any questions or concerns.
