This plan is approved as written with these conditions of approval. The S-4 location will need to be addressed in more detail at 3 foot the BTEX is still 164 and must be below 50 and the TPH is much higher than can be approved. This being said more excavation will be required and depths must be identified were both the BTEX and TPH are within allowable limits. **This plan still needs to be approved by OCD.** BLM approval of this proposal does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to groundwater, surface water, human health, or the environment, or if the location fails to reclaim properly. In such an event that location

does not re vegetate, or future issues with contaminants are encountered, the operator will be asked to address the issues until contaminant issues are fully mitigated and the location is successfully reclaimed. In addition, BLM approval does not relieve the operator of responsibility for compliance with any other federal, state, or local laws/regulations.

Your proposal for remediation of the above referenced release is approved with the following conditions:

In the area identified as S-4, OCD would request the area be excavated through the 3' interval, the area then be further delineated (horizontal and vertical) with respect to the existing light end hydrocarbons/VOCs, to determine the suitability for in-situ bioremediation.

Please advise if proposed excavation depths are not achieved.

Federal sites will require like approval by BLM.
