The OCD cannot approve this work plan because it doesn't provide a full vertical delineation. Please select a location close to the release source to obtain this delineation, preferable SP3 or SP4 (or a point in between the two). A single location to show the full vertical extent should suffice. Delineation goal for chlorides is 250mg/kg.

Once this has been achieved, the OCD should be able to approve this work plan.
