After further review of this site it appears that the playa is on State land, not private land as stated in our meeting. The OCD CANNOT approve using soils from around the playa lake from State land as backfill. This permission must be obtained from the State Land Office. You may contact Dana Strang at dvstrang@slo.state.nm.us for this permission.

The excavation depths we discussed in our meeting are still approved by the OCD.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
