Vacuum truck was called to remove standing oil and backhoe called to remove impacted soils. Excavated soils will be hauled to a NMOCD approved facility. If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure.
