I just finished sampling Section 2 of the release area.

North Sidewall - 832 ppm
East Sidewall - 436 ppm
South Sidewall - 1,612 ppm
West Sidewall - 832 ppm
Bottom of Excavation at 1.5' - 716 ppm

The south sidewall shows elevated chlorides over 1,000 ppm; however, we cannot excavate anymore from that sidewall. We are as close to the wellhead and pump jack that we can get safely. To excavate anymore out of that wall would compromise the stability of the pump jack and put our contractors at a risk for their safety.

Yates requests permission to backfill Section 2.

Heather,

We started excavation of the Buho BQH State #1H last week.

On Friday I was able to visit the site and complete chloride field testing for Section 1 of the release area. The chloride field test results for Section 1 are as follows.

North Sidewall – 772 ppm

East Sidewall – 516 ppm

South Sidewall – 716 ppm

West Sidewall – 328 ppm

Based off these results, Yates is requesting permission to continue with liner installation and backfill of Section 1 of the release area.

Contractors were not through with excavating Section 2 on Friday, and I hope to return today or possibly tomorrow to complete field testing on it. As soon as I have the results, I will send a second email outlining those results.

Amber,

The OCD is in receipt of your work plan for the above referenced release. Your proposed work plan is approved with the following conditions:

- Due to the age of sampling and possible vertical and lateral migration, the OCD requests side wall confirmation samples (chlorides only) for sections 1 and 2 and a bottom hole sample from section 2.
- The OCD will accept your site ranking of 10, but bear in mind that per the Guidelines for Remediation of Leaks, Spills, and Releases the site ranking is determined by the lower most point of contamination to groundwater, which has not been fully determined in this case.
