In regard to the remediation plan submitted by your contractor to remediate the above referenced release, OCD requests and notes the following:

• OCD has no record of having received a Form C-141 reporting this release in 2014. The submittal received 9/28/2016 has been processed and assigned tracking number 2RP-3917.

At this time, OCD requests that no later than November 10, 2016, samples be obtained from the "stockpile" on location and submitted for laboratory analysis for BTEX, TPH (GRO, DRO, MRO) and chloride content. Samples are to be obtained, at a minimum, by dividing the stockpile in quarters. A 5-point composite sample is to be obtained from each quarter and submitted for analyses. In addition, a complete delineation of the former tank battery area, and all areas affected, is to be performed. All soils returning contaminant values above regulatory limits are to be excavated and transported to an OCD approved disposal facility. The project is to be completed not later than November 28, 2016, with a closure report and Final C-141 submitted to OCD not later than December 5, 2016.
