

There was a failure of a chemical line at the well head causing the release.

Describe Area Affected and Cleanup Action Taken.* The release impacted the area on the production pad around the wellhead as well as running northwest and southeast, but remaining on the production pad. A vacuum truck was dispatched to retrieve standing fluid. Impacted soils will be excavated and hauled to a NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. **Depth to Ground Water: >100' (approximately 120', Section 34, T20S-R25E, per NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on enclosed analytical results, EOG Y Resources, Inc. requests closure.**
