Brett,

I picked that point for several reasons, so I will bullet point them:

- It is near S-3, which showed the highest contaminant values at depth.
- In looking at Google images, there may have been some pooling in that area (which probably accounts for the elevated numbers). Picking what would seem to be the "worst" spot should allow for an evaluation of the entire impacted area.
- I don't want to have you drill anymore borings than is absolutely necessary for an adequate evaluation.
- It is at the edge of the pad and should be out of the way of day to day ops at the facility, and be easily accessible for a rig.

I would certainly consider any other options you may want to offer.
