According to Form C-148's submitted by Devon, the last time 2RF-105 was used, was in December 2015. The last C-148 submitted was for September 2016. On November 1, 2016 I requested the August 2016 C-148 to complete submittals through September 2016. That email was ignored, so Devon is missing August 2016 for 2RF-103, 2RF-104, and 2RF-105. No submittals have been received until now. 2RF-105 went out of compliance in June 2016 as far as usage, and all facilities have been out of compliance for reporting on C-148 and for reporting cessation of use. At this time, your request for an extension for 2RF-105 is **DENIED**. An audit will be performed on the remaining facilities in District 2 for compliance issues as well.
