Section 13 Township 17S Range 29E

The release occurred on 12-22-2016 at approximately 7:00 AM.

Estimated Released: Approx. 15 bbls of Oil & 25 bbls of Produced Water

Estimated Recovered: Approx. 10 bbls of Oil & 20 bbls of Produced Water.

This release was caused by a flowline leak on a buried fiberglass flowline. This release occurred on the lease road and in the pasture. A vacuum truck was dispatched to recover the standing fluid.
