Hello Bob,

Yes I appreciated you reaching out to me last week regarding this one. I must ask may you please include Mike Bratcher from my office on anything that is sent to OCD District 2. I have included him above and will be coordinating with him regarding this message and this spill before we will have an answer back to you. Also as I mentioned on the phone, and what I now confirming even further from the images you have sent, it appears that this release is all on state land. I had informed Brett Fulks that the original coordinates provided to us were not seeming correct, so he personally made an effort to collect the correct coordinates, and when I use what he gave me I get the same location as you have marked with a pin on your google earth map you provided (32.287758, -103.937149) and when I use the surface ownership layer on my map I show all of the release to fall on state land. **Thus I have included Amber Groves in this email chain and also attached the initial C-141 for her reference.** If I am incorrect with that determination please help me to get corrected.

As I said Mike Bratcher and I will discuss this incident and get back to ASAP with our thoughts on the matter.

Subject: Devon Laguna Salado South #1 release

Ladies:

I have spoken to both of you regarding the Laguna Salado South # 1 release for Devon last Friday.

I have attached a Google Earth map reflecting the pathway of the spill. As you can see, the spill followed the roadway until the very west end where it followed a two track road for approximately 107'. I have also attached a photo page. The photos are from the evening of the release, the day after and finally several from last Friday. This road is well traveled by oilfield traffic and the path of the release is now only barely visible.

My purpose in sending this information is to obtain guidance from each agency regarding any require delineation of this site. In the past, releases in road may not require any remediation however, I am happy to follow your guidance in making this determination.

Groundwater in the area is relatively shallow, however, no information found on the quality of the water in the area. There is a windmill about 200' from the release area.
