Mr. Price,

Thank you for offering that moving forward Agua Sucia will be more considerate in reviewing all documents before submitting them to us. Thanks for also giving us options on how to handle corrections on our C-141 form. However, OCD has decided to go along with neither of your suggestions and will be leaving the form as is since, as of late, we have already made the effort to make more corrections on Agua Sucia's documents than we would have preferred to.

**Also please note:** You have stated what your process of intent is, but let me be clear in stating our requested expectations. If you refer to the emails that were sent out by the OCD each release received a response from our office that asked for a site characterization plan or a plan of action by a certain date. **For the release at the East Shugart Unit Battery/Water Station 2RP-4393 we received the C-141 as almost a month past due, so please send out a status update on this site immediately.** Also the other two releases (2RP-4391 and 2RP-4392) **require a status update or a site characterization by tomorrow 10/4/17.** (Our administrative team had to back out everything in our system and redo all entries for 2RP-4392 so I am now just sending the response attachment for that one in this email but like I stated in the yellow highlighted area all three C-141s were provided on the same date so an update for both 2RP-4391 and 2RP-4392 is required by 10/4/17.)

It appeared that AS finally got these reports in to you and you accepted them for the file.

I have reviewed these C-141's and unfortunately there still appears to be some discrepancies. It looks like the form showed these sites were in Chavez County, in which they are actually located in Eddy County.

You can either correct them like Maxey does over in Hobbs, or I can resubmit. If you want me to resubmit, just let me know and I will do that ASAP. We apologize for this inconvenience on your offices.

Starting Today, all C-141's will have a second peer reviewed before being submitted. In the future please address all environmental issues to Price LLC. Feel free to use E-mail.

In addition, I plan on performing a Phase I Audit of the entire field and will want to meet with both OCD and BLM in the very near future.
