## Greetings,

The proposal submitted by SMA, on behalf of WPX, is <u>not</u> approved as submitted. Part 2.0 of the submittal indicates a site ranking of 10, based on depth to ground water being less than 100' bgs. The chart lists "Total Site Ranking" as zero. For clarification, site ranking is 10. Part 4.0 of the submittal indicates "composite" samples will be obtained for delineation. Composite samples will not be allowed for delineation of this site. Part 4.0 also requests deferral of the entire location. Deferral will not be considered until the site has been adequately, and completely delineated. Figure 2, location map, shows a yellow outline of the affected area. The outline does not include the southeast corner of the site and a portion of the road that appears to exhibit chloride impact. More than one delineation point will be required at this site, and is to include the area just mentioned. <u>Please resubmit a proposal that shows how SMA will adequately delineate the site</u>. Final disposition may then be considered based on analytical data. <u>Please submit this proposal not later than 11/9/2017</u>.
