operator, to provide advisement or training of *proper sampling technique* or *offer up some standardized sampling procedure*. Fasken Oil and Ranch needs to make the decision for themselves on how to proceed with these projects or Fasken Oil and Ranch needs to hire a third party Environmental Contractor to do so. Aside from that <u>OCD does expect, as has been stated</u> **previously, that more than one sample needs to be collected from each of your bio remediation piles.** How Fasken Oil and Ranch decides to interpret that and proceed will be up to you all. OCD will engage in no further comment or negotiation regarding the matter.

For small stockpiles such as this one and the El Paso Federal 12, one sample for BTEX/TPH should be sufficient.

What I do not want is to collect one sample from each stockpile and you ask for more analysis after I send the lab reports to you. It is an approximate 5.5 hour round trip for me to get to the EL Paso Federal 12—add another hour to that if I include the Gossett in that trip....I'll basically use a day to go collect samples. With that in mind, I really don't want you to ask me for additional samples that would require an additional trip: it simply uses a huge amount of time when we can make a plan now and avoid an extra trip.

As with El Paso Federal 12:

I am requesting acknowledgement of completion/closure on the clean-up portion of the spill, not the stockpile or disposal of the stockpile.

I am quite sure the concentrations have attenuated. I will comment that most of the material that was removed at the Gossett is pea gravel, so analysis might be a bit tough....the lab can't 'wash' pea gravel to get the sample extracted for analysis. As with El Paso Federal 12, I think we will just send the stockpile for disposal if concentrations are too high—but I doubt it with this one. Like the other

spill: Do you want one composite sample (what was previously collected), or a specific number of grab samples? This is also a very small stockpile; roughly approximately 10 to 15 yards. Since it is a small amount of pea gravel, I think operations would like to re-use onsite, assuming the analysis passes muster.
