Your proposal for remediation of the above referenced release is**not** approved. Based on Table 3, there is no analytical data for L1 until the 2' interval. There is no analytical data for L2 until the 4' interval, and it is a field screen for chloride. No hydrocarbon data at all (this was reported as an oil release). L3 only shows a field screen for chloride at 2'. Again, no hydrocarbon data. Figure 2 site map shows a sample point L5, but there is no data at all for that sample point.

Also, again, the first paragraph of the proposal states the site is on State surface and then later indicates Federal surface. Cut and paste isn't working too well for you.

Please resubmit a proposal that adequately defines potential impact at this site.
