### Rebecca/Cliff,

I am currently looking at the work plan for 2RP-4240 but this email sent back on 9/2017 said that you all were going to make progress sometime soon on the other 3 open older releases that are related to West Brushy 8 SWD #1. So I just wanted to follow up with you all on what the plan is for these along with inquire where you all are at on 2RP-4330.

- 2RP-4094 has a work plan approved since 4/2017 thru BBC International.
- 2RP-3353 had been proposed by Lupe Carrasco and Robert Grubbs from COG for deferment and asked to leave all contamination (aside from a surface scrape) in place and that deferment proposal was declined by OCD back in 4/2016 and I don't have anything else on record for this one since then.
- 2RP-3774 has no work plan submitted, but I do show that according to the spill site map that this release has some overlap release area that is compatible with 2RP-4240 which I am currently working on reviewing a work plan for 2RP-4240. So in my write up for work plan for 2RP-4240 OCD will request that both releases be dealt with at the same time if practicable.
- Now for my last question, the 10,000+bbls release of 2RP-4330 has a work plan written by BBC International that was approved on 10/30/17. Has any progress been made on this one? We will need a status report on this one since it is the larger of all and the most concerning regarding potential for migration to the Pecos river/possible shallow ground water(due to proximity to the river). Please advise on the status of this one ASAP.

Please provide an overall plan of action for the entire set by no later than 2/23/18.

I have included a scanned copy of the signed Initial C-141 Remediation Permit along with an attached Conditions of Approval. The OCD tracking number for this event is 2RP-4240.

PLEASE NOTE: I was also looking in the files for this site location to see if there were any other remediations that we needed an update on and I came across case number 2RP-3353. Could we please get an update on that one. I have attached OCD's last response to COG and I also attached BLM's request on 6/13/16 for an update. Also 2RP-3774 which BBC International Inc. was contracted to work has not had an update to us since 3/1/17. BBC International states in the email that attached above that the remediation effort for 2RP-3774 will also incorporate a clean-up of the extent of 2RP-3353. So maybe following up with 2RP-3774 will cover follow up of both of these that I have requested. Also may we please get an update on 2RP-4094. I also attached a copy of the last correspondence from OCD which was a work plan approval to BBC International on 4/6/17.

Further Note: There have been 7 spills that have occurred at this site location starting since 2014. Therefore, OCD at this time would like to pose the question to COG regarding whether or not a root cause analysis has been conducted for this site location and if any considerations have been made regarding potentially replacing the poly-flow line (if it is the same one that has had reoccurring issues) or if anything further can be done to also prevent the reoccurring pw tank overflow issue.
