OCD concurs with BLM approval of the proposal for remediation of the above referenced release, with the following:

- OCD requests additional data from sample points identified as L1 and L2 to meet delineation goals of 600 mg/kg (chloride)
- The site diagram depicts a sample point identified as L5 at the NW end of the impact area, (approximately 100 yds from L4), however there is no analytical data provided for that sample point. OCD requests, minimally, bottom hole data to confirm delineation goal.

All of the requested additional data may be obtained post excavation. Please advise once remedial activities have been scheduled.
