BLM has received and reviewed a hard copy of the proposed procedure. BLM approves the plan with the following stipulation:

1. Reseed with Alpomado Seed Mix. All disturbed surface area has to be reseeded.

BLM also approves for the additional area needed for the treatment cells off location.

Please note the area is in medium Karst and approx 60' from FEMA floodplain. The area has been cleared for archaeology and sensitive species, other than the Alpomado Falcon already noted.
