Your proposal for remediation of the above referenced release is approved with the following:

- Confirmation samples are to be obtained 90 days after excavation activities.
- Confirmation samples are to be obtained in 1' vertical increments with a minimum of 2 samples obtained at each sample point, below excavation bottom.
- Confirmation samples required to verify horizontal extent has been defined/addressed.
- Federal sites will require like approval from BLM.

Lab analytical data is required with submittals, but please include the data in a table format for future submittals. Also please reference the RP number on all correspondence.
