If the release ran off from the well pad that is located approximately where the coordinates on the C-141 indicate then the PLSS Unit Letter that was involved would either be Unit Letter F or K. According to the description written on the form it seems that Unit Letter K is most suitable but we shall let you all decide on that. Another discrepancy is that the form is marked as a <u>Final</u> form. OCD will not be accepting a Final form for this release prior to an Initial form being submitted. **Please revise and resubmit so that the corrected form can be processed.** All spills require proper implementation of remediation to be initiated and completed according to OCD rules, regs and Conditions of Approval.
