Henryetta: Please note that the OSE document you are referring to is incorrect. There was a period of time when OSE wanted <u>all</u> borings permitted through them. There was even some discussion on hand auger borings. The document that lists groundwater at 80' was actually a delineation boring performed by an environmental contractor. No groundwater was encountered. Any protectable ground water in that area (17s-30e) should be well below 300'. Please contact me if you want to discuss.
