Even though delineation was not 100% defined vertically for T-1 it is very close. OCD will approve this work plan due to how long it has sat waiting on approval and the fact that this spill is relatively small in size according to what was reported.

This work plan is approved as I mentioned however discrete laboratory tested confirmation samples for both sidewalls and bottom hole will be required.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
