Since this well was shut in for investigation has any production fluid leaks been detected? This is to notify you on 1.15.2018 at 9:30 AM XTO discovered a pressure relief valve (PRV) had released on the Big Eddy Unit 167 well site. This well had been shut-in since 8.17.2017 and at this time it is unknown the volume of gas released. The well has been further isolated and the PRV is no longer releasing. No injuries or other environmental impacts occurred from this event. We will provide details with the submission of a form C-141.
