NMSLO approves of the plan as written with the following comments. Confirmation samples are required on the sidewalls of the area around SP-2 to ensure the area is adequately delineated and remediated. The seed mix has gramma grass and sideoats gramma in the mix, I not sure what gramma grass is planning on being used (Blue Grama Im thinking?) Also the seeding rate is light, 5lbs/acre. Typical rates are around 13-20 lbs/acre and doubled for handbroadcasting (the method planning on being used). I would suggest increasing the seeding rate.
