We had a release at the Cottonwood Hills 32 State Com 1 Battery Production Equipment today at 11:40 AM.

The 3" water piping coming off the heater treater developed a leak due to corrosion that developed on the threads of pipe. We replaced the pipe today and power washed the containment .

We had 60 barrels of produced water released into a lined containment and we recovered all fluids.

I will send in the C141 once Christine or I have laid our eyes on the containment.
