Hello Mr. Brunson,

OCD has received the C-141 Remediation Plan report. This remediation plan has been denied for the following:

1. Area is in medium karst remediate to Table 1 DTW < 50' including Chlorides < 600 mg/kg, TPH < 100 mg/kg.
2. All delineation samples to test for all 4 constituents at each elevation, spill area still needs a more complete delineation.
3. Areas around SP3 & 5 should be excavated to 5', SP2 & 4 excavated to 2'.
4. No photos of spill area and no GPS photos of spill area, OCD is unable to confirm information presented or if any of the spill went off pad which would require restoration to 19.15.29.13 NMAC.

Please let me know if you have any questions. Also note that OXY has 30 days to request hearing following any denial of remediation plans or closures.
