Please find the attached closure report for the leak at the OXY Cedar Canyon 28 Federal #4 (2RP-2868). This is the leak that we discussed that previous remediation activities had been done by Talon LPE, but since we had no records available to us, you requested confirmation sampling be conducted to verify that no contaminants were left behind. You requested sample depths to be at least to 4 feet. As you can see from the results, this leak was remediated. Therefore, Oxy is requesting closure for this site.
