## Good afternoon,

NMSLO denies the risk based closure request. The closest well I could find was in the USGS database, and was located about 4200' to the SW and has a depth of 16 feet the last time it was measured. Because of this information the site required further delineation. Also the TPH seems high to me for a produced water release. The site need to be delineated to 600ppm chloride, 100ppm TPH, 50 BTEX, and 10ppm Benzene. Finally, my inclination, even without seeing full delineation data would be to deny deferral. Deferral is for production equipment and facilities. This looks be to located in an area where remediation is feasible.
