Due to a lack of work being performed by the third party COG will be remediating the spill. Initial samples have been collected with a hand auger and samples are at the lab. Depending on sample results it may be necessary to revisit the site with a backhoe to obtain deeper samples which could not be collected with the hand auger due to a hard formation present after six inches.
