Mr. Bratcher/Mr. Amos,

Please find the attached C-141 for your consideration. The calculation sheet to determine the estimated release volume is also attached. The liquid lost estimate is based on the spill dimensions and estimated depth of fluid (wet gravel depth). The spreadsheet will calculate the volume lost in the gravel, but does not include the recovered amount in the calculation. The calculated volume in the gravel and the volume recovered were added together and reported on the C-141.
