NMSLO doesn't approve of the plan as written. Because of the location of the release remediation should be conducted to 600ppm for chloride with clean non material backfilled. This should be able to be achieved by excavating the entire area 2-3 feet. After this the site should be revegetated. Let me know if you have any questions.
