The remediation plan has the Yellow shaded area on the diagram being excavated to a depth of 6 inches. The first layer of uncontaminated material is at 1 foot. The contamination was found at the surface, but none at the 1 foot layer. We don't know if the contamination ends at 2 inches or 11 inches, so please excavate down to 1 foot in the Yellow shaded area on the diagram and replace with clean material.
