Cause of Release: A 6" pipeline fusion coupling detached at a connection allowing produced water to be released. At the release point, released fluid saturated proximal surface soil before pooling, then flowing west down the pipeline ROW until encountering a drainage channel which trends to the south-southwest and crosses State Line Road. After crossing State Line Road, released fluid continued to flow down the drainage channel to the south-southwest before terminating in rural pasture land.

Based on the size of the pipeline, the pipeline's pressure, the size of the leak at the connection, and the estimated time of 1-2 hours of elapsed time before the release was discovered and isolated, it is estimated that 1000 barrels (990 bbls) of produced water and contained crude oil (10 bbls) were released with 118 bbls of produced water and 2 bbls of crude oil recovered as free standing liquids. Presently, the pipeline is shut-in as a new coupling has been installed at the connection.
