During that time we were just submitting the Initial Pages from the C-141 and once the RP number was assigned we were interpreting that as we needed to treat it as a liquid release. Since then we were asked to submit the applicable closure pages during the initial submission for our dry gas releases if we wish for them to closed out. I went ahead and completed the remaining pages for these two, relatively old releases along with supporting pictures demonstrating that there weren't any liquids.
