Please find the attached C-141 for your consideration. Also, attached is the calculation sheet to determine the estimated release volume for Falcon Lined facilities. The liquid lost estimate is based on the spill dimensions and estimated depth of fluid in the liner. The spreadsheet will calculate the volume lost into the liner. No gravel was present in this lined facility as it is a Falcon Liner. The unrecovered volume is a residue left behind on the liner and equipment which will be cleaned by pressure wash.
