- Information on groundwater depth (water well data, data archived in the NMOSE, etc.)
- Laboratory results should be provided as evidence of delineation efforts.
- Include a scaled sitemap that shows where the 57 delineation samples were taken.
- To evaluate your request to modify the closure sampling requirements, submit a scaled sitemap with the approximate locations of the proposed confirmation samples. Please note that according to the form C-141 "Characterization Report Checklist" & "Remediation Plan Checklist" a scaled sitemap showing impacted area, surface features, delineation points and monitoring well must be included in the plan.
- Finally, keep in mind that NMOCD no longer uses the risk based ranking system to evaluate the remediation action levels.
