Cause of Release: EOG received information that water was spraying from an EOG water gathering system double tin horn located in the field approximately 100-feet north of New Mexico Hwy 128 in Eddy County, NM, at GPS coordinates: 32.285530°, -103.786315°. The water was shut off and vacuum trucks were called to pick up the water inside the tin horns. A valve failure on the poly water gathering line caused the release. The valve was repaired and the line returned to service. Approximately 85 bbls of produced water released from the line and 78 bbls was recovered.
