## Hello Kevin,

I will call you back tomorrow. Sorry for the delay we have been in meetings all day today and for the most part all of this week.

I can give you something to chew on per se for in the meantime that will more or less cover what I am going to say for the most part when we do talk.

Since I heard that you are based out of Texas (Houston I think) and I have not worked with you before, then I am feeling it may be safe to assume you are not entirely familiar with how release remediations work when dealing with the State of New Mexico. So I will give you the same info I gave Jonathon Solis (I apologize if he already forwarded this stuff to you).

If you are looking for guidance I would suggest four things:

- Go to our website and look at OCD Rules and Regulations for spill reporting section 19.15.29 NMAC and spill remediation section 19.15.30 NMAC. Here is the link <a href="http://www.emnrd.state.nm.us/OCD/documents/SearchablePDFofOCDTitle19Chapter15-Revised10-5-16.pdf">http://www.emnrd.state.nm.us/OCD/documents/SearchablePDFofOCDTitle19Chapter15-Revised10-5-16.pdf</a>
- 2. The Conditions of Approval (COAs) that I sent to you (it is attached to the C-141 that I signed and sent back to you), is a good document to follow on how to conduct a remediation to OCDs current expected standards.
- 3. Then if you still need clarification I would go on OCD Online and search and look at other previously done remediation projects by other operators that are recent and that may give you an idea of what we are looking for. If I were you and I were going to do this step, then my advice would be make sure you look at more than one project. Cause some are not done well and others are done well, so it is good to look at a few to get a comparison. - 4. Most operators hire a third party environmental consultant group to do their remediation projects on their behalf. So that would definitely be ideal for you all to consider.

I hope this helps get you moving in the right direction.

So now that I have sent you the COAs your next step in the process would be to delineate your site and give us a work plan.

For you I will reattach the C-141 (the COAs document is part of that same attachment) since I am not

sure if you have received a copy of all that yet or not.
