A question came up on today's OCD conference call about trying to close multiple RP-Numbers on a single report. We were told by the OCD Environmental Bureau Chief that multiple RP-Number Reports will require a payment for each RP-Number. In the case of this Report on the "Avalon Delaware Unit #562", it would require 2 payments of \$150 (one for each RP-Number). Generally, The \$150 fee applies to: 1. Initial C-141 2. Remediation Plan or Deferral 3. Closure Report Each form requires a separate fee if sent in separately. If a Remediation-Closure Report was sent in on the same report, it would only require 1 payment of \$150 instead of 2. Essentially, the OCD is incentivizing operators to close spills as quickly as possible. An Initial/Final C-141 Report would also require only 1 fee. If the form is incomplete or denied, the forms will be charged an additional \$150 fee at resubmission. Please let me know if you have any questions,
